## **2009 Proposals Granted**

**\$2,740,585**

1. **Visiting Nurse Association of the Inland Counties** **\$15,000**  
To provide funding for the Mourning Star Children's Grief Support Program, which will provide a bereavement support group for children and their parents or caregivers.

2. **Loma Linda University Children's Hospital** **\$221,725**  
To support the Pediatric Wholistic Medicine Clinic, which will provide primary care to children from the City of Riverside as well as consultative holistic services for other physicians.  
**Inpatient Distribution/ November 2008**
3. **Inland Agency** **\$120,000**  
To provide funding for the Women's Health Initiative, which will provide breast cancer screening and treatment for eligible women age 39 and younger residing in the City of Riverside.  
**Outpatient Distribution/ November 2008**
4. **The Epilepsy Center** **\$2,500**  
To support the Epilepsy Empowerment Conference which seeks to empower those with epilepsy and educate the community about the social, medical, and psychological impacts of epilepsy.

5. **American Heart Association** **\$3,000**  
To support American Heart Association's annual Go Red for Women Campaign, which provides a health expo, a monthly newsletter, and luncheons for the purpose of encouraging women to take charge of their heart health.

 To support Grantmakers in Health, a non-profit educational/resource organization, and its programs, which assist and support foundations to respond to the complex and rapidly changing health system.

- 12. MFI Recovery Center, Inc. **\$65,000****  
 To provide a contract physician and a contract nurse for the Center's medical screening and well-baby care program, which provides medical detoxification and well-baby care for pregnant and parenting drug abusing women and their children.

- 13. IEHP Health Access **\$500,000****  
 To provide insurance for Riverside children through the Healthy Kids Program, a comprehensive health coverage to uninsured children under age 19 who live in families with income at or less than 250% of Federal Poverty Level (FPL), do not qualify for Medi-Cal or Healthy Families, and live in Riverside County for 90 consecutive days.  
**Inpatient Distribution/May 2009**
- 14. Riverside Community College District Foundation **\$200,000\*****  
 To provide dental units for the Riverside Community College (RCC) Dental Hygiene Clinic, which provides preventative dental services to children, adults, and the elderly while training students of the RCCD Dental Hygiene Program.  
**Outpatient Distribution/May 2009 (\*\$100,000 out of 2009 funds; \$100,000 out of 2010 funds)**
- 15. Purpose Center **\$1,500****  
 To support the Purpose Center and the 5<sup>th</sup> annual Healthy Heritage Wellness Conference (HHWC), which provides African Americans with culturally sensitive health facts in the areas of behavioral health, nutrition, and physical activity. The event also offers free medical screenings and HIV/AIDS testing.

- 16. American Diabetes Association **\$2,000****  
 To support American Diabetes Association's annual *Step Out Walk to Fight Diabetes*, which features a Wellness Fair component with diabetes information, advocacy and local resources for the public, in addition to providing an opportunity for the community to engage in a fitness regimen in preparation for the event.

To support the Arlanza Family Health Center Pediatric Dental Program, which provides pediatric dentistry services for Arlanza's uninsured and underinsured children. Pediatric dental services include screenings, cleanings, treatment, and general anesthesia for treatment of severe early childhood caries.

To provide funding for the purchase of five (5) Rapid Response Extracorporeal Membrane Oxygenation (ECMO) systems which provide a child's heart and lung function when disease has caused heart and/or lung failure.

- 32. The Epilepsy Center **\$1,500****  
To support the Epilepsy Empowerment Conference 2010 which seeks to empower those with epilepsy and educate the community about epilepsy, as well as address the medical, social, academic and financial questions surrounding the disease.
