\$2,160,297

- 1. Operation SafeHouse** **\$20,000**

To support a Licensed Marriage and Family Counselor to provide mental health counseling to older homeless youth ages 18 to 21 through its 24-month Main Street Transitional Living Program, the goal of which is to break the cycle of homelessness by giving young adults the tools to meet challenges of education, physical and mental health, social behavior, and the ability to seek and obtain employment and permanent housing.

Outpatient Distribution/ November 2011
- 2. Care Connexus, Inc.** **\$75,000**

To support dependent adults requiring daytime supervision at the Care Connexus Adult Day Services Center of Riverside, through the provision of direct patient nursing services and assistance to support patients who have lost insurance coverage due to the elimination of Medi-Cal coverage for individuals in adult day programs.

Outpatient Distribution/ January 2012
- 3. Riverside County Regional Medical Center** **\$300,000**

To support the establishment of a new residency training program in internal medicine and primary care clinic for chronically disabled individuals with complex medical needs, through a partnership between Riverside County Regional Medical Center and the University of Riverside School of Medicine.

- 4. Family Service Association** **\$60,000**

To support the Healthy Communities Mental Health Services program, which provides comprehensive counseling treatment services to families and individuals who have experienced child abuse, domestic violence, divorce, separation, or who are struggling to cope with other economic or family stressors that impact their overall well-being and quality of life.

Outpatient Distribution/ January 2012
- 5. Blindness Support Services** **\$20,000**

To support Team BSS, which focuses on promoting health and wellness of individuals who are blind or visually impaired, and seniors ages 55 and older. The program offers health seminars; training classes on exercising, healthy eating, and walking; organized health and fitness activities; and opportunities to participate in competitive community walks.

- 6. Inland Agency** **\$80,000**

To provide funding for the Pink Ribbon Place Breast Cancer Resource Center, which provides breast cancer screening and treatment for eligible women under 40 residing in the City of Riverside.

- 7. The Epilepsy Center** **\$2,000**

To support the Epilepsy Empowerment Conference 2012, a free conference designed to teach clients and their families and care providers more about epilepsy and how to access various services.

| | To support the “Healthy People 2012” conference, which will focus this year on Healthy Aging. The mission of the conference is to collaborate, share information and develop strategies for achieving a new level of success in creating healthy communities.

| 9. | Fiesta Educativa, Inc. | \$1,500 |
| | To provide a full day conference for Spanish-speaking Latino families, focused on providing information on available health services, interventions, practices and other services that will allow individuals with developmental disabilities to live in a more inclusive and natural environment.

Campaign to reduce obesity rates in Riverside.

- 16. Boys & Girls Clubs of Redlands** **\$10,000**
To support “Triple Play”—an after-school program for Boys & Girls Club members ages 6 to 18 demonstrating skills for a healthy lifestyle including nutrition, physical activity, and healthy relationships; in addition, the program promotes education for parents of participants.

- 17. Borrego Health** **\$334,120**
To support the expansion of specialty care and the improvement of health outcomes by eliminating the need for offsite referrals to X-ray and routine eye exams through the addition of optometry and radiology clinical service at the Arlanza Family Health Center.
Outpatient Distribution/ May 2012
- 18. Riverside County District Attorney’s Office** **\$2,500**
To support the Riverside County District Attorney’s Office as the lead agency hosting “The Lisa Project”, a multi-sensory and interactive exhibit designed to bring awareness and prevention to the issue of child abuse and neglect.

- 19. 100 Mile Club** **\$10,000**
To provide funding for low income children in the city of Riverside to participate in the 100 Mile Club, a school-based program that encourages children to run or walk 100 miles during one school year earning incentives while increasing their physical fitness levels and learning healthy habits.

- 20. Inland Empire Health Plan** **\$350,000**
To provide insurance for Riverside children through the Healthy Kids Program, a comprehensive health coverage to uninsured children under age 19 who live in families with income at or less than 250% of Federal Poverty Level (FPL), do not qualify for Medi-Cal or Healthy Families, and live in Riverside County for at least 90 consecutive days.
Inpatient Distribution/ July 2012
- 21. Riverside County Physicians Memorial Foundation** **\$59,000**
To support Project K.I.N.D. in addressing immediate medical or dental needs of uninsured children ages 5 to 17 by providing no cost access to quality medical, dental, and optical care to assist in returning the child to school as soon as possible.

- 22. Loma Linda University School of Public Health** **\$3,000**
To support the Healthy Communities by Design Summit 2012, providing a forum to exchange ideas on environmental factors that affect health and to discuss new community planning approaches that incorporate health considerations.

- 23. Riverside County Regional Medical Center Foundation** **\$145,000**
To fund the purchase of eight new cardio-respiratory monitors and one central monitoring station, replacing the current, nearly 15-year-old monitoring equipment and providing technologically advanced monitoring capabilities for the Riverside County Regional Medical Center’s Pediatric Intensive Care Unit.

24. **Center for Community Action & Environmental Justice** **\$10,000**
To support the SALTA (Salud Ambiental Lideres Tomando Acción) Program, an outreach program that engages and organizes low-income Latino residents to address local health needs involving air quality and chemical toxins, through health education and leadership development training.

25. **Olive Crest** **\$30,000**
To support a health technician and case manager to provide health education to and oversee the health treatment of at-risk youth in one of Olive Crest's residential group homes, as well as to teach the youth how to develop ongoing relationships with health care professionals after their discharge from the program.

26. **Planned Parenthood of the Pacific Southwest** **\$43,865**
To support a part-time case management nurse to help patients navigate care within and beyond Planned Parenthood of the Pacific Southwest's scope of services; the case management nurse will connect patients to the care they need in a timely, culturally and linguistically appropriate manner.

27. **MFI Recovery Center** **\$70,000**
To provide medical screening for infectious diseases, medical detoxification services and counseling for substance-abusing women, as well as well-baby care and immunizations for their children ages 0 to 12.

28. **Loma Linda University Children's Hospital Foundation** **\$263,955**
To support the development of a Neuro Neonatal Intensive Care Unit (NICU) within the Loma Linda University Children's Hospital, which will allow the Neuro NICU team to utilize both equipment and expertise to closely monitor the brain activity of infants at risk for seizures and brain injury.

29. **Borrego Health** **\$219,313**
To support a pilot program providing adult dental services to low income families in the Eastside Health Center and Arlanza Family Health Center service areas.

To support the Give Kids A Smile ® program, providing free oral health education and oral health care services to children from low-income families in the city of Riverside during the month of February.
